Mayor Carr Lays Out Options For Future City Water Supply

To the Editor:

The city of Maumee has a contract with the city of Toledo for the purchase of water that extends through 2026. This agreement currently results in our residents paying the lowest cost for water of any community in Northwest Ohio other than Toledo residents. Based upon what other communities are paying for water, when our contract expires, our residents will likely see their water bills triple at the very least. The time it would take for Maumee to become part of a new system with new water lines installed is such that Maumee must decide now the direction we will take when our existing contract expires.

For many years, water, which with Lake Erie is one of our region's greatest assets, has been subject to politics, monopolies and contracts resulting in ridiculous purchase costs for individuals and business owners.

The city of Toledo is in a position where they are mandated by the Ohio EPA to address safety issues and redundancy (to prevent a water crisis like we woke up to in 2014). That cost will exceed \$500 million, and appears to be \$600 million. There are nine suburban contract customers, which include Maumee, and if we remain customers of the city of Toledo without a change in existing structure of ownership of the Collins Park water plant, our residents will be paying a share of these \$600 million improvements at a ratio disproportionate to Toledo residents. And, after the \$600 million has been paid, we still would have no ownership interest and no control whatsoever over how much our residents are paying for water.

Over the past two years, I have attended many, many meetings on this issue. There is an urgency to our situation even though 2026 sounds a long time away. I have worked with all of the other suburban mayors toward the goal of a regional water system that provides governance and an ownership of the Collins Park treatment plant for suburban communities. A regional water system that is fair and provides suburban communities, which would be paying for over 50 percent of the \$600 million mandated repairs and upgrades, with an ownership interest is ultimately best for our entire region.

However, the city of Toledo is not currently agreeable to any real governance or ownership participation for suburban communities. In fact, its last proposals were that we pay for our share of the \$600 million in mandated repairs and in

exchange we can have a board that makes recommendations to Toledo City Council or that a regional board be established with appointments to the board initially made by the city of Toledo and the Lucas County Commissioners. Those offers were not only wholly unacceptable; they were, in my opinion, insulting.

Over the last year, I have had several meetings with various representatives of entities in Wood County to determine if Maumee could purchase water from Bowling Green. The city of Perrysburg has been an active participant in those discussions and we are working together. The city of Waterville began to purchase its water from Bowling Green this year.

Maumee is not acting as a "renegade." Sylvania is seriously exploring its own new system (the cost of extending lines all the way to Maumee from Sylvania is too expensive for us to consider this alternative), and Oregon has its own water plant.

All participating communities were asked to approve a resolution supporting a regional water system. I requested, and the Toledo Metropolitan Council Government regional water committee unanimously approved, that the resolution provide that all participating communities have a "meaningful voice in the governance" in such a system. Every participating community, except Toledo, approved the resolution with that language. Toledo's City Council deleted the word "meaningful." In other words, I take it that Toledo will listen to what such a governing board has to say, but ultimately they want us to pay our share of the \$600 million in repairs and they will continue to do what they want to do. That is not acceptable.

Water prices are going to increase. Perrysburg has already approved annual 8-percent increases for its residents. How much water rates increase will ultimately be determined by how we proceed. A study is currently being completed that will provide us with information needed to understand the costs and logistics of connecting to Bowling Green water, if that option is provided to Maumee.

What I can assure our residents and businesses is that we are working tirelessly to protect your interests. We will do what is right for our residents and those who own businesses in our community. We cannot and will not find Maumee under the continued Toledo water monopoly when our contract expires in 2026.

Street trees are important in Maumee. We have well over 10,000 in the city. Not only do trees help beautify the city, but they are also responsible for helping to clean the air that we breathe. The City of Maumee is

proud of its many and varied street trees and its multiyear status as a Tree City USA through The National Arbor Day Found-

The Department of Public Service is responsible for all trees in the public right of way. Typically the right of way extends from approximately 1 foot in back of the sidewalk across the street to 1 foot in back of the sidewalk on the other side of the street. The city reserves the right and the responsibility to care for all the trees in the right of way. We spray and trim

the trees as needed. If you believe your street tree needs attention, please call instead of attempting the work yourself.

We annually

plant several hun-

dred street trees to replace trees taken down and also to fill in areas where street trees are missing. If you are lucky enough to receive a street tree, please take good care of it. Do not damage the base of the tree with your lawn mower or weed whacker, and please water the tree when you water

Whether we are replanting a large evergreen or planting one small tree as part of an Arbor Day celebration at a local school, every tree is important; please help us to take care

the lawn.

Think Fire Safety This Spring

Spring Into Fire Safety Smoke Detectors

- Smoke detectors must be working to save lives. Families should test alarms monthly, replace batteries twice a year and replace the smoke detectors every 10 years.
- If you rent an apartment or home, your landlord must provide working smoke detectors. Contact your landlord immediately if you do not have any.
- If do not have smoke detectors, or need help installing one, contact the Maumee Fire Division, as we can help.
- Develop and practice a home fire escape plan.

Home Safety

- Clear leaves, debris and other yard waste from around the home, garage and sheds.
- Fuels for lawn and garden equipment, tools and vehicles should only be stored in approved containers.
- Check for frayed or damaged electrical cords and wires, and have them repaired by a qualified professional.
- Air conditioning units and electrical cords should be checked.
- Barbeque gas grills, including gas hoses, gas grill lines and propane tanks, should be inspected prior to use.
- Dispose of hot coals properly douse them with plenty of water and stir them to ensure the fire is out. Never place them in plastic, paper or wooden containers.
- Keep any combustible material 3 feet away from hot water tanks, clothes dryers and vents and any heating equipment.
- Remove any lint buildup from clothes dryers.Take stacks of newspapers and magazines to
- recycling centers.
 Get rid of oily rags and cloths used to wipe
- Get rid of only rags and cloths used to wipoup fuel spills.
- Clean up work areas by putting away dangerous tools, adhesives, matches and other items that should not be accessible to children.

Severe Weather Safety

Be Informed — Have a weather radio and sign up for severe weather text alerts.

Make a Plan — Have a family communications plan. Keep family contacts up to date.

Build a Kit — Have enough food, water and supplies for at least 72 hours after a disaster.

Know the difference between a watch and a warning. A watch means weather conditions are possible for severe weather or tornadoes, and a warning means severe weather or a tornado is coming and you need to take shelter immediately. For more information on disaster preparedness, visit www.ready.gov.

The main focus is to teach preschoolers who will be starting kindergarten in the fall many different aspects of safety. The children will learn about safety on the roads, bus safety (including a bus ride), water safety, animal safety and fire safety, along with many other fun activities. The cost is \$30.00 for Maumee residents or children who attend Maumee schools. The non-resident fee is \$40.00 and is dependent upon program openings. Division Of Building And Zoning Inspection Provides Information

Spring and summer are the busiest seasons for the Building and Zoning Office, including property maintenance violations in the City of Maumee. While there are some major violations and nuisances that we are working to get corrected, a majority of the violations we find are less serious and easily corrected. Many times, property owners are not aware of the code requirements until they receive the violation notice from our office.

Take a survey of your property. Peeling paint, broken windows, damaged roofing materials? Tall grass, weeds and debris? Please maintain your property, as you only get one chance to make that first impression. The most common viola-

Recreational Vehicles in the Front Yard: Recreational vehicles include boats, jet skis, campers, trailers, ATVs and other similar types of equipment. You can park or store your RV on your property as long as it is further from the street than the front of your house or your neighbor's house, whichever has the greater set-back.

Parking in the Front Yard: Vehicles may not be parked in the grass or yard areas closer to the street than the front of your house.

Pools Temporary Without a Permit: All pools with a surface area greater than 100 square feet or containing water over 18 inches deep require a permit and must meet all additional code requirements for location, fencing and electrical connection. This includes the

temporary-style popular pools that are designed to be taken down over the winter. After obtaining a permit for a temporary pool, you are not required to get a new permit each year as long as the pool is put up in the same location.

Painting: The Property Maintenance Code requires that all peeling, flaking and chipped paint be eliminated and the surface repainted.

General Maintenance: Keep the grass cut. Remove weeds, brush piles, animal feces and all debris from your property. Place all debris in secured waste receptacles and properly dispose of waste. Please refrain from feeding birds and squirrels as this may invite unwanted rodents into your neighborhood.

Please check with the Building and Zoning Department prior to starting any home and/or business improvement. Material and labor costs are expensive and the possibility of corrective action after the work has commenced is not a costeffective way to improve your property. Also beware of contractors requesting and/or requiring the property owner to obtain the permits. Chances are these contractors are not registered to perform work in Maumee and may be out to misrepresent themselves and take advantage of owner financially. Required permits are the least expense of an improvement project. If utilizing a contractor, require a copy of the permit and receipt prior to work commencing and/or any type of payment.

FINAL READINGS. When you move or sell your property, a final reading is required to remove your name from the account. Call (419) 897-7125 or (419) 897-7127 to schedule a final reading. We do not need access to your home to do this. Also, please make sure that a proper forwarding address is reported.

SWIMMING POOLS IRRIGATION. Sewer charges are based on water usage. If you have a meter installed to record the water used for irrigation or a swimming pool, that usage will be excluded from sewer charges. In lieu of metered usage, the city allows a oncea-year pool credit for filling or topping off a pool. In order to qualify for a pool credit, you must read the meter inside your home before you start your pool fill and after the pool fill is completed. Then call in your readings. There will be no exceptions. If you call with no meter readings, you will not get your pool fill credit. Please call those readings into the Utility Billing Office at (419) 897-7125 or (419) 897-7127. Do not read the outside remote, as that is now obsolete.

Lucas County Recycling Tips

Plastic bags, although recyclable at many local grocery stores or retail outlets, should not be included in the drop-off or curbside streams. A bigger issue is actually having recyclables placed in the bins in plastic bags. These bags can literally tie up the machinery used to sort the recyclables. Therefore, processors are required to pull the unopened bags from the stream and label them as trash. The key message here is to ask residents to place all recyclable items into their bins loose, not bagged.

For a complete list of recycling options, residents can go to the district or Keep Toledo/Lucas County Beautiful Inc.'s (KT/LCB) website (www.ktlcb.org) and search the Recycler's List for places to take materials that are not accepted at drop-offs or in curbside recycling programs.

Fertilize Your Lawn If You Must, But Don't Fertilize The Water

The Toledo Metropolitan Area Council of Governments (TMACOG) and the Stormwater Coalition remind people that fertilizer should be applied to lawns sparingly and caringly. And it should stay on your lawn and not get into the storm sewer system, where it affects our streams and lakes.

A little care will save you money and will also protect streams and lakes.

First, use only as much fertilizer as you need. A simple soil test will tell you if you need to add nutrients. If you do want to fertilize, use a noor low-phosphorus fertilizer, and select a slow-release fertilizer where at least half of the nitrogen is water-insoluble.

Then, don't let your fertilizer wash away into the storm sewers, where it will end up in streams and lakes. If we get a rain right after you fertilize, you'll watch your investment flow right to the storm sewers, and fertilizer does not belong in the water supply. Do use a broom to sweep excess or spilled fertilizer off the sidewalks and back onto your lawn; don't use a hose that will wash fertilizer into the street and then into sewers.

Excess amounts of nitrogen and phosphorus can cause blooms of algae in our lakes and streams. Some algae is natural and is part of the food chain, but overgrowth of algae forms mats of goo that clog water inlets and block sunlight to the water. As algae decay, they use up oxygen in the water that fish,



frogs and other wildlife need.

There are ways to keep a lawn green and healthy that are 100-percent free and ecologically sound. When you mow, leave the grass at least 3 inches tall, and leave the clippings on the lawn. Grass clippings will quickly break down and enrich the soil. You can also make your own organic fertilizer in a home compost bin. Kitchen waste like vegetable peels and eggshells, combined with leaves and grass clippings, will create rich compost that will keep a lawn or garden healthy and growing.

City Of Maumee Offers Various Yard Waste Disposal Options

Yard waste is not included in the regular refuse collection. Yard waste may be handled by residents through home composting, through the yard waste collection service provided by Republic Services or through utilizing the available yard waste dropoff facilities.

Yard Waste Collection Service

Republic Services' brown yard waste bags are available for purchase at Rite Aid in Maumee for \$3.50 per bag. The Republic Services seal must be on the side of the bag. Generic bags will not be picked up by Republic

Services. The bags must be placed at the edge of the pavement no later than 7:00 a.m. on the day of collection. The purchase price covers the cost of the collection service and composting of the item.

Collection occurs every Tuesday from March 7 through December 5, 2017.

Rules Regarding Grass And Noxious Weeds

Grass and Noxious Weeds Nuisances

accordance with Chapter 915 of the Maumee Municipal Code, any person owning or having charge of land within the City of Maumee, Ohio shall keep the grass cut to a height not in excess of eight inches (8"). They shall keep same free and clear from all noxious weeds and rank vegetation on such lots owned or controlled by said owner to prevent such rank growth

and/or the maturing or spreading of seeds or pollen there from.

Any person or entity owning, occupying, or having charge of land abutting upon a public right of way shall keep the grass on the unpaved portions of the right of way abutting the land cut to a height not in excess of eight inches (8") and shall keep the same free and clear from all noxious weeds and rank vegetation as required to prevent such rank growth

and/or the maturing or spreading of seeds or pollen there from.

On undeveloped property that is not immediately adjacent to developed residential or commercial property within the city, the owner may submit a plan for the creation of a "managed natural area" for approval to the director of Public Service or his designee. The plan for the "managed natural area" may include grasses and vegetation in excess of the height limitations of this section; provided that such area shall not contain any rank vegetation or noxious weeds as set forth above. A "managed natural area" may only be created and maintained in accordance with a plan submitted to and approved by the director of Public Service or his designee.


If compliance is not made with this notice and the provisions of Chapter 915 of the Maumee Municipal Code within five (5) days after the date of this notice, then such grass, weeds and other vegetation will be cut by or on behalf of the City of Maumee, and the cost and expenses thereof will be assessed against the respective lots or lands. Violators will be prosecuted pursuant to the provision of Charter 915 of the Municipal Code.

Spring 2017 Chippable Brush Collection

Starting the week of MARCH 27, 2017, the City of Maumee will be providing its SPRING CHIPPABLE BRUSH COLLECTION. This collection is for CHIPPABLE MATERIAL ONLY. NO yard waste bags or non-chippable material (leaves, grass, garden waste, weeds, etc.) will be collected as part of this program. The chippable material must be bundled and tied in four foot (4') lengths, no more than two feet (2') in diameter and weigh no more than forty (40) pounds. The material should be put out to the street by the Sunday before a districts pick up week.

Refuse And Recycling Tips

Toters should be placed out before 7:00 a.m. on day of pickup and returned to the residence the same day. Cardboard boxes are not acceptable containers.

Furniture, TVs, mattresses, appliances, carpet and other large items are defined as "bulk items" and require a "bulk tag." These tags can be purchased at Rite Aid in Maumee for \$15.00 for one or three for \$30.00. They must be attached and visible to the driver for pickup. These items must also be scheduled for pickup with Republic Services by calling (800) 234-

Please try to avoid getting furniture and mattresses wet if possible. Soaked bulk items make pickup for drivers very difficult and may delay pickup.

If you have additional bags that will not fit in your black trash toter you may place them next to the toter for pickup if you purchase "bag tags" at Rite Aid in Maumee for \$3.50 each. They must be attached and visible to the driver for pickup.

and other areas of concern.

A click of an icon shows a brief description of the call along with the date and a police report number.

programs such as overnight business checks and the senior outreach program, our efforts have increased "calls for service" by 17 percent in 2016 from the previous year (2015). We strive daily to prepreventative efforts to in- vent crime before it occurs and desire to work with the citizens to accomplish our mission.

There are two free and beneficial programs available to assist senior citizens who reside within the City of Maumee First, the "RUOK?" program (started in 1988) is a

daily telephone call to check on the senior's well-being. The participant gets to choose the time of the call — the options are 8:00, 9:00, 10:00 or 11:00 a.m. or noon. The resident can easily contact the front desk to be removed if there is a conflict with their schedule for a particular day, week or even month.

The daily telephone call is generated by a computer but monitored by front desk personnel. If the phone call is not answered after two attempts, a police crew is sent to the home to check on the participant's safety and well-being. The officer also has access to vital information on key availability and emergency contact(s).

Secondly, a new program was just launched (2016) called the "Senior Outreach" program. This program involves a regular weekly check-up by a uniformed officer to ensure that the person's basic needs are being met. It is extremely beneficial for those who may be "homebound" or with little outside assistance. Referrals can be made for assistance along with important information relayed to the citizen concerning scams/cons, garbage carryout service, the citywide "Code Red" system, etc.

through our Tax Connect Online filing system and then may submit their W-2 forms to the office once the return is filed.

Estimated tax payments are mandatory for any taxpayer that expects to owe \$200 or more for the tax year.

The penalty rate for failing to pay estimated tax payments is 15 percent and the interest rate is 6 percent per annum for 2017.

The first quarterly payment is due on Tuesday, April 18 and the forms can be obtained at our website or by calling the tax office.

Tax return balances and estimated tax payments can be paid in person (by cash, check and credit/debit card with no fees), through the mail (by check), or online through Tax Connect (by credit/debit card or account

The tax office is available to prepare tax returns or accept payments on weekdays between the hours of 8:00 a.m. and 4:30 p.m.
