### **7. CONSENT CALENDAR**

- A. Recommendation** from the City Administrator:  
Authorize a one-year agreement with P&R Communications Services, Inc. for 2021, in the amount not to exceed \$4,080.00 for Police Division radio equipment maintenance.
- B. Recommendation** from the City Administrator:  
Authorize Provident Insurance Accidental Death & Dismemberment insurance coverage for a three-year renewal period, 2/1/2021 to 2/1/2024, for the Maumee Fire Division, at a cost of \$18,448.00.

- C. Recommendation** from the City Administrator:  
 Authorize a one-year agreement with P&R Communications Services, Inc. for 2021, in the amount not to exceed \$8,553.00 for Fire Division radio equipment maintenance.
- D. Recommendation** from the City Administrator:
