Sidewalk and Driveway Permit:

The cost shall be based upon the following:

- (a) Sidewalks involving less than 40 square feet of construction or reconstruction \$ 20.00
- (b) Sidewalks and driveways involving more than 40 square feet of construction or reconstruction \$ 50.00
- (c) Cutting or dropping of curbs \$ 50.00
 Plus add per each lineal foot \$ 2.00

CODE CHANGES AS OF JULY, 2020

- 1136.12(l) All residential driveways shall have a concrete approach and a hard-surfaced driveway of concrete or plant-mixed bituminous material in accordance with specifications of the city. Approaches must have a compacted six (6) inches thick base and be six (6) inches thick, concrete, with the sidewalk floating separate from approaches. The maximum width of a residential approach shall not exceed twenty (22) feet at the curb line which includes tapers and 20 feet wide in the front yard of a structure or property. The minimum asphalt depth for driveways must be three (3) inches. The minimum concrete depth for driveways must be four (4) inches. Up to two (2) dwellings may be permitted to share a driveway provided it complies with these construction standards.
- 1141.08(f) Sidewalks and Crosswalks. Sidewalks and marked and/or raised crosswalks shall adequately provide for the safe movement of pedestrians in all parking areas except in one or two-family residential use. Sidewalks in the public right-of-way must float separate from the approach and be of different material than the approach, unless concrete. The material, location and width of all sidewalks and crosswalks shall be approved at the discretion of the Zoning Administrator and the Plan Commission (if required), but at no time shall the required width of any sidewalk be less than five (5) feet for residential and six (6) feet for commercial, or more than twelve (12) feet.

- Requests for variations to these ordinances due to existing conditions may be considered by the Zoning Administrator or his designee at the request of the home owner or contractor. Work completed prior to the issuance of a permit shall not be weighed in this decision.

In consideration of granting this permit, I agree to hold the City of Maumee harmless from all damages. I do hereby agree to construct said work in all respects in compliance with the ordinances of the City of Maumee and rules and regulations of the City Administrator. Permit fees are not transferable or refundable.

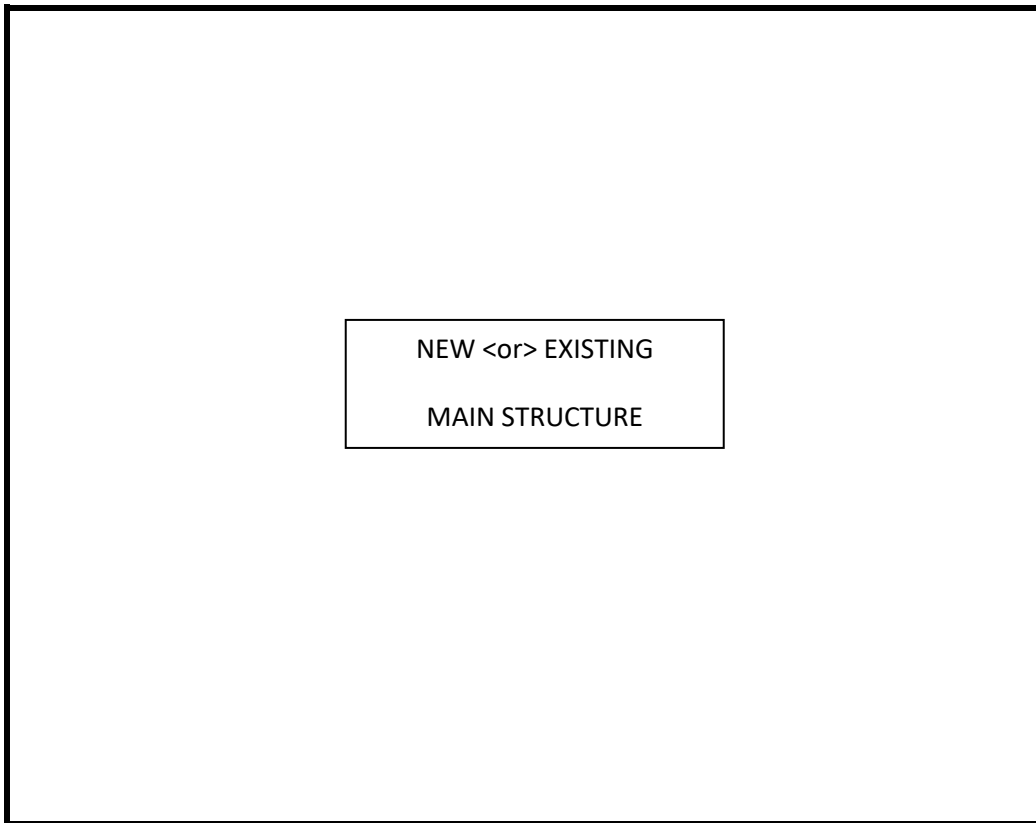
